Domestic Animals Act 2000, Section 144 - Determination of Fees

1. Pursuant to section 144 of the *Domestic Animals Act 2000* (the Act) I **REVOKE** the Determination No DI 2002 – 83 dated 20 June 2002 and notified on the ACT Government Legislation Register and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.
2. The fees for services provided are specified in the Schedule hereunder in Column 2 and prices for 2003-2004 are specified in Column 4 opposite, in relation to that service. Where applicable, GST inclusive fees are marked with a double asterisk (**).
