Disallowable Instrument DI2004-186

Road Transport (General) Act 1999, Section 96 - Determination of Fees, Charges and Other Amounts

1. Name of instrument

This instrument is the Road Transport (General) (Fees) Determination 2004 (No 2).

2. Revocation

I revoke disallowable instrument numbers **DI 2004-126, DI 2000-180 and DI 2001-117** as notified on the ACT Government Legislation Register.

3. Determination of fees

The fees for services provided are specified in the Schedule hereunder in Column 3 and prices for 2004-2005 are specified in Column 5 opposite, in relation to that service.

Where applicable, GST inclusive fees are marked with a double asterisk (**).

- (i) subject to paragraph (ii), the fee payable in respect of the section of the *Road Transport (Dimensions and Mass) Act 1990* specified in the attached Schedule shall be the fee specified in the Schedule for that section; and
- (ii) where a vehicle is a vehicle of a kind referred to in Part 3 of the Schedule to the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth), the charges in that Schedule shall apply.

Explanatory notes (including the previous year's fee) are at Column 4 and are included in the Schedule. Explanatory notes are included at the end of the Schedule, where applicable. Headings and explanatory notes in the Schedule do not form part of the determination. (For example: where new fees for 2004-05 are denoted by an "N/A" in 2003-04, if included in the schedule, would not form part of the determination).
