Electricity Safety Act 1971, Section 128 - Determination of Fees

1. Pursuant to section 128 of the **Electricity Safety Act 1971** (the Act), I **REVOKE** the Determination No DI 2003 – 160 notified on the ACT Government Legislation Register and I **DETERMINE** that the fees for the purposes of the Act shall be in accordance with the Schedule.
