Electoral (Fees) Determination 2005

Disallowable instrument DI2005—149

made under the

Electoral Act 1992, s 8 (Determination of Fees)

1. The ACT Electoral Commission **REVOKES** disallowable instrument No. DI2004-159 (Electoral (Fees) Determination 2004).
2. The ACT Electoral Commission **DETERMINES** that the fees payable for the purposes of the Act are as set out in the Schedule.
3. The ACT Electoral Commission **DETERMINES** that fees are payable by persons or organisations receiving the goods or services specified in this determination.
4. The ACT Electoral Commission **DETERMINES** that fees are payable to the ACT Electoral Commission.
5. The ACT Electoral Commission **DETERMINES** that fees are payable after a service has been supplied, by the due date specified in the invoice for the service.
6. Explanatory notes (including previous fees) are included in the Schedule in italic text. Explanatory notes in italic text do not form part of the determination. 7. This determination shall take effect on the day after the determination is notified under the *Legislation Act 2001*.
