# Road Transport (General) (Driver Licence and Related Fees) Determination 2006 (No 1)

#### Disallowable instrument DI2006-127

made under the

*Road Transport (General) Act 1999*, section 96 (Determination of fees, charges and other amounts)

### 1. Name of instrument

The name of this instrument is the *Road Transport (General) (Driver Licence and Related Fees) Determination 2006 (No 1).* 

#### 2. Revocation

I revoke instrument no DI2005-82, notified on 9 June 2005.

### 3. Licence related fees

- (a) I determine that the fee payable after 31 July 2006 for the grant or renewal of a driver licence or other matter mentioned in Schedule 1, column two is the amount mentioned in column four.
- (b) I determine that subject to paragraph 3(c) of this determination, the fee payable on or before 31 July 2006 for the grant or renewal of a driver licence or other matter mentioned in Schedule 1, column two, is the amount mentioned in column three.
- (c) I determine that the fee for a renewal of a driver licence, where the licence being renewed expires after 31 July 2006 is the fee mentioned in column four for renewal of a licence of that type, even if payment is made before 1 August 2006.

# 4. Payment of Fee

A fee payable under this determination applies is payable to the road transport authority by the applicant for the driver licence or other matter to which the application relates.

# 5. Commencement

This instrument commences on the day after notification.

#### Formula For Short Term Licence Periods

Where

- A full licence is issued or renewed for a period other than five years, or

- A provisional licence is issued or renewed for a period other than three years -The fee payable shall be the five-year fee for a full licence divided by sixty and multiplied by the number of months for which the full or provisional licence is issued or renewed. Any part of a month shall be treated as one month.
