1. Name of Instrument

This Instrument is the Road Transport (Public Passenger Services) Maximum Fares for Taxi Services Determination 2006 (No 1).

2. Revocation

I revoke determination DI 2005-129 dated 27 June 2005 and notified under the Legislation Register on 30 June 2005.

3. Determination

I determine that the maximum fares relating to hiring or using a taxi are as specified in the Schedule.

4. Payment of Fare

A fare to which this determination applies is payable by a customer for using taxi services and is payable to the taxi driver.

5. Commencement

This instrument commences on 1 July 2006.
