Race and Sports Bookmaking Act 2001, s21(1) - Determination of sports bookmaking venues

1. Name of Instrument

This Instrument is the Race and Sports Bookmaking (Sports Bookmaking Venues) Determination 2006 (No 9).

2. Revocation

I revoke determination DI2006-214 dated 26 September 2006 and notified under the Legislation Register on 3 October 2006.

3. Commencement

Schedule 1 of this Instrument commences on the day after notification.

Schedule 2 of this Instrument is deemed to have commenced on 5 September 2006.

4. Determination

I determine that the area within 1 (one) metre of any selling terminal, owned and operated by ACTTAB Limited and located within the places identified in the Schedules to this instrument, as sports bookmaking venues.

For the purposes of this determination “selling terminal” means:

1. SELPOS selling terminal; or
2. AMTOTE AT 1000 selling terminal.
