Citation

1. This Statute may be cited as the University of Canberra (Academic Board) Amendment Statute 2007 (No 1).

Commencement

2. This Statute commences on the date of notification.

Interpretation

3. In this Statute:

Principal Statute means the Academic Board Statute 1990;
Act has the same meaning as in the Academic Board Statute 1990;
Board has the same meaning as in the Academic Board Statute 1990;
Chairperson has the same meaning as in the Academic Board Statute 1990;
designate body has the same meaning as in the Academic Board Statute 1990;
student has the same meaning as in the Academic Board Statute 1990;
faculty has the same meaning as in the Academic Board Statute 1990.

Amendment of Section 2 of the Principal Statute

 Section 2 of the Principal Statute is amended by inserting the following definition: *academic division* means an 'other body' determined by the Council under section 8 of the Act;

Amendment of Section 3 of the Principal Statute - Membership of the Board *Name amended under Legislation Act, s 60

5. New subsection 3(1)

- 5.1 Omit the existing subsection 3(1) and substitute the following:
 - 3.(1) The Board consists of the following members:
 - (a) the Vice-Chancellor or his or her nominee; and
 - (b) the Chairperson appointed by Council under section 21 of the Act; and
 - (c) the heads of academic divisions (or faculties) determined by Council under section 8 of the Act; and
 - (d) the heads of other bodies designated by Council under paragraph 20(d) of the Act; and
 - (e) up to four professors, who are not members of the Board under another paragraph of this subsection, elected by the members of the academic staff who have been appointed as professor by the Council; and
 - (f) one member of the academic staff of each academic division (or faculty) elected by the academic staff members of that division (or faculty), under rules made under this Statute; and
 - (g) the member of the general staff elected by members of that staff to be the member of Council under paragraph 11(1)(f) of the Act and appointed to Academic Board by Council under paragraph 20(g) of the Act; and
 - (h) one member of the academic staff elected by members of that staff to be a member of the Council, under paragraph 11(1)(e)of the Act: and
 - (i) one undergraduate and one postgraduate student elected from among their number by the students of the University, under rules made under this Statute; and
 - the person or persons (if any) appointed by the Council after (i) receiving the advice of the Board, under paragraph 20(g) of the Act.
 - 3.(2) Not more than six people (including any appointment made under paragraph 3(1)(g) of this Statute) may hold appointments under paragraph 20(g) of the Act at any one time.

Amendment of Section 4 of the Principal Statute - Terms of Office

6. Section 4 - Terms of Office

6.1 Subsection 4.(2)

Omit the reference to paragraph 3(1)(f) or (g) and substitute 'paragraph 3(1)(e) or (f)'

6.2 Subsection 4.(4)

Omit the reference to paragraph 3(1)(f), (g), (i) or (j) and substitute 'paragraph 3(1)(e), (f), (i) or (j)'
