

Dangerous Goods (Road Transport) Fees and Charges Determination 2010 (No 1)

Disallowable instrument DI2010–41

made under the

Dangerous Goods (Road Transport) Act 2009, section 194 (Determination of fees)

1 Name of instrument

This instrument is the *Dangerous Goods (Road Transport) Fees and Charges Determination 2010 (No 1)*.

2 Commencement

This instrument commences on the day after its notification.

3 Meaning of *regulation*

In this instrument:

regulation means the *Dangerous Goods (Road Transport) Regulation 2010*.

4 Approval of packaging design

The fee for the making of an application for an approval under section 48 (Applications for approval of packaging design) of the regulation is \$348.00.

5 Approval of segregation devices

- (1) The fee for the making of an application for an approval under section 116 (Approvals—segregation devices) of the regulation is \$348.00.
- (2) The fee for the making of an application for reinspection of a device that is refused an approval on an application mentioned in subclause (1) is \$57.00.
- (3) The fee for the reinspection of the device is \$57.00 for each hour, or part of an hour, of the reinspection.

6 Exemptions, administrative determinations and approvals

- (1) This clause applies to the making of an application under the following provisions of the regulation:
 - (a) section 168 (Applications for exemptions);

- (b) section 174 (which is about applications for an administrative determination or approval or the variation of a determination or approval);
- (2) The fee for the making of the application is \$348.00.

7 Dangerous goods driver licences

- (1) The fee for the making of an application under section 197 (Application for licence) or section 202 (Applications for renewal of licence) of the regulation is \$68.00.
- (2) The fee for the making of an application under section 221 (Replacement licences and licence labels) of the regulation for the issue of a replacement licence is \$40.00.

8 Dangerous goods vehicle licences

- (1) The fee for the making of an application under section 209 (Applications for licences) or section 212 (Applications for renewal of licences) of the regulation is—
 - (a) if the application is for 1 vehicle—\$178.00; and
 - (b) if the application is for more than 1 vehicle—\$178.00 for the first vehicle and \$50.00 for each additional vehicle to which the application relates.
- (2) The fee for the making of an application for reinspection of a vehicle that is refused a dangerous goods vehicle licence on an application mentioned in subclause (1) is \$57.00.
- (3) The fee for the reinspection of the vehicle is \$57.00 for each hour, or part of an hour, of the reinspection.
- (4) The fee for the making of an application under section 221 (Replacement licences and licence labels) of the regulation for the issue of a replacement licence label is \$40.00.

9 Payment of fees and charges

A fee or charge under this determination is payable to the Territory by the applicant for the thing or service to which the fee or charge relates.
