
## Electoral (Fees) Determination 2012

Disallowable instrument DI2012—138

made under the

### Electoral Act 1992, s 8 (Determination of Fees)

1. This determination may be cited as *Electoral (Fees) Determination 2012*.
2. This determination takes effect on the day after the determination is notified under the *Legislation Act 2001*.
3. The ACT Electoral Commission REVOKES disallowable instrument No. DI2011-181 (Electoral (Fees) Determination 2011).
4. The ACT Electoral Commission DETERMINES that the fees payable for the purposes of the Act are as set out in the Schedule.
5. The ACT Electoral Commission DETERMINES that fees are payable by persons or organisations receiving the goods or services specified in this determination.
6. The ACT Electoral Commission DETERMINES that fees are payable to the ACT Electoral Commission.
7. The ACT Electoral Commission DETERMINES that fees are payable after a service has been supplied, by the due date specified in the invoice for the service.
8. Explanatory notes (including previous fees) are included in the Schedule in italic text. Explanatory notes in italic text do not form part of the determination. (For example, the following nine words, if included in the Schedule, would not form part of the determination: [*Explanatory note: general explanatory notes are in italic text*]).
