Disallowable Instrument DI 2013-170

Road Transport (Public Passenger Services) Act 2001, section 60 (power to determine maximum taxi fares)

1. Name of Instrument

This instrument is the Road Transport (Public Passenger Services) Maximum Fares for Taxi Services Determination 2013 (No 2).

2. Revocation of Previous Instrument

Disallowable Instrument DI2013-77 (as notified on the ACT Government Legislation Register) is revoked.

3. Determination

I determine that the maximum fares relating to the hiring or use of a taxi are as specified in the Schedule.

4. Payment of Fare

A fare to which this determination applies is payable by a customer for using taxi services and is payable to the taxi driver.

5. Commencement

This instrument commences on 1 July 2013.
