

# Health Professionals (Veterinary Surgeons Fees) Determination 2014 (No 1)

## 1 Name of instrument

This instrument is the *Health Professionals (Veterinary Surgeons Fees) Determination 2014 (No 1)*.

## 2 Commencement

This instrument commences on 1 January 2015.

## 3 Revocation

This instrument revokes DI2013-53.

## 4 Determination of fees

The ACT Veterinary Surgeons Board determines the fees set out in schedule 1 to be the fees for registration of veterinary surgeons and other matters.

## 5 Payment of fee

The fees are payable to the ACT Veterinary Surgeons Board by the person requesting the service.

## 6 Additional fees

- (1) An application either for registration as a veterinary specialist or short-term registration is subject to an additional fee payable by the person seeking either service. These fees are identified in schedule 1 as an 'additional fee'.
- (2) A fee for approval of registration out-of-session is applicable to all applicants who wish to be registered at times other than board meetings. This fee is identified in schedule 1 as 'Surcharge for out-of-session registration'.
