Fair Trading (Motor Vehicle Repair Industry) Act 2010, s 55 (Determination of fees)

1 Name of instrument

This instrument is the *Fair Trading (Motor Vehicle Repair Industry) (Fees) Determination 2015*.

2 Commencement

This instrument commences on 1 July 2015.

3 Revocation

This instrument revokes DI2014-123, the *Fair Trading (Motor Vehicle Repair Industry) (Fees) Determination 2014*.

4 Determination of fees

- (1) The fee payable for a matter stated in an item in the schedule, column 2 is the fee stated in the schedule, column 3 for that matter.
- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

5 Payment of fees

The fee payable for a matter stated in an item in the schedule, column 2 is payable to the Territory.

6 Payment by instalments

The fee payable may be paid by quarterly or yearly instalments.
