### **1 Name of instrument**

This instrument is the *Hawkers (Fees) Determination 2015*.

### **2 Commencement**

This instrument commences on 1 July 2015.

### **3 Revocation**

This instrument revokes DI2014-126, the *Hawkers (Fees) Determination 2014*.

### **4 Determination of fees**

- (1) The fee payable for a matter stated in an item in the schedule, column 2 is the fee stated in the schedule, column 3 for that matter.
- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

### **5 Payment of fees**

The fee payable for a matter stated in an item in the schedule, column 2 is payable to the Territory.

### **6 Payment by instalments**

The fee payable in items 375-377 may be paid by quarterly or yearly instalments.
