1 Name of instrument

This instrument is the *Veterinary Surgeons (Fees) Determination 2015 (No 1)*.

2 Commencement

This instrument commences on the commencement day of the *Veterinary Surgeons Act 2015*.

3 Determination of fees

The ACT Veterinary Surgeons Board determines the fees set out in schedule 1 as fees for registration of veterinary surgeons, veterinary premises and other miscellaneous matters.

4 Payment of fee

The fees set out in schedule 1 are payable to the ACT Veterinary Surgeons Board by the person requesting the service.

5 Additional fees

- (1) An application for registration as a veterinary specialist is subject to an additional fee payable by the person seeking the additional registration. These fees are identified in part 3 of schedule 1 as an 'Additional fee'.
- (2) A fee for consideration of registration applications, including renewals, out-of-session is applicable to all applicants who wish to be registered at times other than board meetings. This fee is identified in schedule 1 as 'Surcharge for out-of-session registration'.
