# Road Transport (General) Application of Road Transport Legislation Declaration 2016 (No 13)

Disallowable instrument DI2016—290

made under the

Road Transport (General) Act 1999, section 13 (Power to exclude vehicles, persons or animals from road transport legislation)

### 1 Name of instrument

This instrument is the Road Transport (General) Application of Road Transport Legislation Declaration 2016 (No 13).

### 2 Commencement

This instrument commences on 3 December 2016.

#### 3 Third-party insurance declaration

(1) The *Road Transport (Third-Party Insurance)* Act 2008 does not apply to a designated vehicle while being used to participate in a stage of the Rallye des Femmes for any period beginning when an event official declares (in whatever manner the event official describes) the stage active for a testing session, media event, corporate event day or rally competition and ending when an event official declares the stage inactive.

*Note* A reference to an Act includes a reference to the statutory instruments made or in force under the Act, including any regulation (see Legislation Act, s 104).

- (2) However subclause (1) does not apply if the designated vehicle is—
  - (a) covered under a policy of compulsory third-party insurance of a place other than the ACT or under a law of the Commonwealth; or
  - (b) subject to coverage under a compulsory motor vehicle or trailer accident compensation scheme of a place other than the ACT or of the Commonwealth.

# 4 Declaration – other road transport legislation

I declare that:

- the Road Transport (Driver Licensing)Act 1999;
- the Road Transport (Safety and Traffic Management)Act 1999; and
- the Road Transport (Vehicle Registration) Act 1999,

do not apply to an entrant vehicle or the driver of an entrant vehicle, while participating in a special stage of the Rallye des Femmes for any period beginning when an event official declares (in whatever manner the event official describes) the stage active for a testing session, media event, corporate event day or rally competition and ending when an event official declares the stage inactive.

# 5 Definitions

In this instrument:

designated vehicle means any of the following vehicles:

- (a) a registered entrant motor vehicle;
- (b) a registered promotional or official vehicle;
- (c) an unidentified motor vehicle;
- (d) an uninsured motor vehicle.

#### entrant vehicle means:

- (a) a vehicle entered for competition for the Rallye des Femmes, to take part in the stages; or
- (b) a promotional or official vehicle being used for promotional or official purposes during the special stages.

event means the Rallye des Femmes.

*event official* means an official for the event who holds an official's licence from the Confederation of Australian Motor Sport Ltd that authorises the official to declare event stages active or inactive.

*registered* means registered under the *Road Transport (Vehicle Registration)* Act 1999.

*special stage* for the event, means a road or road related area identified for the event on the attached maps:

- Test Stage 1 Old Kowen Road, Kowen Forest;
- Test Stage 2 Welch's Road, Kowen Forest;
- Special Stages 1, 3 and 5 Old Kowen Road, Kowen Forest; and
- Special Stages 2, 4 and 6 River Road, Kowen Forest.



*uninsured motor vehicle*—see the *Road Transport (Third-Party Insurance) Act 2008*, section 60.




