### 1 **Name of instrument**

This instrument is the *Agents (Fees) Determination 2016*.

### 2 **Commencement**

This instrument commences on 1 July 2016.

### 3 **Revocation**

This instrument revokes DI2015-122, the *Agents (Fees) Determination 2015*.

### 4 **Determination of fees**

- (1) The fee payable for a matter stated in an item in the schedule, column 2 is the fee stated in the schedule, column 3 for that matter.
- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

### 5 **Payment of fees**

The fee payable for a matter stated in an item in the schedule, column 2 is payable to the Territory.

### 6 **Payment by instalments**

The fee payable in items 247-251 may be paid by quarterly or yearly instalments.

Fee intended only to recover replacement costs. There is no fee for the issue of a paper certificate (A4 size document).
