# Major Events (Rugby League World Cup) Declaration 2017

#### Disallowable instrument DI2017-196

made under the

Major Events Act 2014, section 6 (Major event—declaration)

#### 1 Name of instrument

This instrument is the *Major Events (Rugby League World Cup) Declaration* 2017.

#### 2 Commencement

This instrument commences on the day after its notification day.

# 3 Major event declaration and description—Act, ss 6 (1) and 7 (1) (a)

The three matches to be held in Canberra as part of the Rugby League World Cup 2017, including three training sessions at the event venue are declared to be a major event.

## 4 Event organiser—Act, s 7 (1) (b)

The organiser of the major event is the Rugby League World Cup 2017 Organising Committee.

## 5 Proposed time and date—Act, s 7 (1) (c)

The proposed times and dates of the major event are:

- (a) 28 October 2017 from 7:00am to 7:00pm (France and Lebanon training session);
- (b) 29 October 2017 from 1:00pm to 10:15pm (France v Lebanon match);
- (c) 2 November 2017 from 7:00am to 7:00pm (Australia and France training session);
- (d) 3 November 2017 from 1:00pm to 10:15pm (Australia v France match); and
- (e) 9 November 2017 from 7:00am to 7:00pm (Fiji and Italy training session);
- (f) 10 November 2017 from 1:00pm to 10:15pm (Fiji v Italy match).

# 6 Event venue—Act, s 7 (1) (d)

The location of the venue for the major event is the grounds, including any buildings situated on the grounds, occupied by GIO Stadium Canberra, Battye Street, Bruce ACT 2617.

# 7 When declaration is in force—Act, s 7 (1) (e)

This declaration is in force for the period—

- (a) beginning at 12:01am on 28 October, ending at 12:01am on 30 October 2017;
- (b) beginning at 12:01am on 2 November 2017, ending at 12:01am on 3 November 2017;
- (c) beginning at 12:01am on 9 November 2017, ending at 12:01am on 11 November 2017.

# 8 Notice given under other provisions—Act, s 7 (1) (f)

A notice may be given under the following provisions for the event:

- (a) Act, section 26 (Notice of protected symbol);
- (b) Act, section 32 (Notice of clean zone).

# 9 Prohibited items—Act, s 7 (2)

The following items are prohibited in addition to those provided by section 12 (1) (a) of the Act:

- (a) beverage containers with manufacturer's seal broken (unless purchased at the Event);
- (b) portable coolers and bags of dimensions greater than 35cm in height, 20cm in width and 30cm in length, or too large to be stored underneath a venue seat;
- (c) camera lenses with a physical length greater than 200mm or any other item which might reasonably obstruct the view of other patrons;
- (d) photographic, video, or audio recording equipment including camera tripods and monopods.

## 10 Expiry

This instrument expires on 20 November 2017.
