Schedule 2 – Category of Premises

Category of Premises	Description of veterinary services offered at premises
1	Veterinary consulting rooms where examinations, diagnostic, prophylactic and medical services are provided and limited to consulting only (no surgical procedures other than minor surgery, no procedures requiring general anaesthesia, no hospitalisation of animals or holding of animals overnight).
2	Veterinary clinics where examinations, diagnostic, prophylactic, medical and surgical services are provided, including surgical procedures under general anaesthesia. Inpatient facilities are provided.
3	Veterinary centres and hospitals where professional consulting services include intensive care of medical and surgical patients, examination, diagnostic, prophylactic, radiology, medical and surgical services. Veterinary centres and hospitals must have at least two veterinary surgeons practising at the premises and a minimum of two examination/consultation areas.
4	Veterinary House Call practices offer house call veterinary services only in conjunction with the other types of practice listed above. Anaesthetic is only administered in emergencies. Anaesthesia should be referred if at all possible but may be used with due regard to animal welfare.
5	Mobile veterinary clinics where clinical veterinary services, including some surgical services, are offered in a vehicle or moveable trailer modified to function as a veterinary facility (no spinal or orthopaedic procedures, no surgical procedures that might require intensive monitoring or overnight hospitalisation).
