1 Name of instrument

This instrument is the Liquor (Fees) Determination 2017.

2 Commencement

This instrument commences on 1 July 2017.

Note: Under section 227(2) of the Liquor Act 2010, the new fees determined for item 501 (renewal of licence) commence 3 months after the notification date for this determination.

3 Revocation

- (1) Subject to 3(2), this instrument revokes DI2016-97, the Liquor (Fees) Determination 2016.
- (2) Item 501 of the *Liquor (Fees) Determination 2016* DI2016-97 is revoked 3 months after the notification date of the *Liquor (Fees) Determination 2017*.

4 Determination of fees

- (1) The fee payable for a matter stated in an item in the schedule, column 2 is the fee stated in the schedule, column 3 for that matter.
- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

5 Payment of fees
