### **1 Name of instrument**

This instrument is the *Liquor (Fees) Determination 2018*.

### **2 Commencement**

This instrument commences on 1 July 2018.

### **3 Revocation**

- (1) Subject to 3(2), this instrument revokes DI2017-92, the Liquor (Fees) Determination 2017.
- (2) Item 501 of the Liquor (Fees) Determination 2017 DI2017-92 is revoked 3 months after the notification date of the Liquor (Fees) Determination 2018.
