### 1 **Name of instrument**

This instrument is the *Agents (Fees) Determination 2020*.

### 2 **Commencement**

This instrument commences on 1 July 2020.

### 3 **Revocation**

This instrument revokes DI2019-123, the *Agents (Fees) Determination 2019*.

### 4 **Determination of fees**

- (1) The fee payable for a matter stated in an item in the schedule, column 2 is the fee stated in the schedule, column 3 for that matter.
- (2) The fee for a matter stated in an item in the schedule, column 2 is payable by the person requesting the service.

### 5 **Payment of fees**

The fee payable for a matter stated in an item in the schedule, column 2 is payable to the Territory.

### 6 **Payment by instalments**

The fee payable in items 247-251 may be paid by quarterly or yearly instalments.

Last Financial Year the fee was \$251.00 for twelve months with a minimum charge of \$73.00 for less than 12 months and \$754.00 for more than 12 months and up to 3 years.</i></p>	<p>\$256.00 apportioned on a monthly or part thereof basis if less than twelve months, with a minimum charge of \$74.00 (GST is not applicable) \$769.00 for more than 12 months and up to 3 years (GST is not applicable)</p>
252	<p>For the issue of a duplicate certificate of registration or a duplicate licence certificate, if the licence certificate is issued in photo ID card format.</p> <p><i>Explanatory Note: Certificates are to be double-sided plastic Photo ID cards. Fee intended only to recover replacement costs. There is no fee for the issue of a paper certificate (A4 size document).
