

# Race and Sports Bookmaking (Fees) Determination 2021

## Disallowable instrument DI2021–179

made under the

**Race and Sports Bookmaking Act 2001, section 97 (Determination of fees)**

### 1 Name of instrument

This instrument is the *Race and Sports Bookmaking (Fees) Determination 2021*.

### 2 Commencement

- (1) This instrument (other than sections 3 and 4, schedule 1, items 3 and 6) commences on 1 July 2021.
- (2) Sections 3 and 4, schedule 1, items 3 and 6 commence on the day after this instrument's notification day.

### 3 Determination

I determine that the fee payable for a matter described in column 3 of schedule 1 is the amount mentioned in column 4.

### 4 Payment of fee

A fee to which this determination applies is payable to the ACT Gambling and Racing Commission by an applicant, an incoming person, an incoming individual and an incoming corporation for the matters to which the application or assessment relates.

### 5 Revocation

This instrument revokes DI2020-156, the *Race and Sports Bookmaking (Fees) Determination 2020*.
