

Road Transport (General) Refund and Dishonoured Payments Fees Determination 2022 (No 2)

Disallowable Instrument DI2022–192

made under the

Road Transport (General) Act 1999, section 96 (Determination of fees, charges and other amounts)

1 Name of instrument

The name of this instrument is the *Road Transport (General) Refund and Dishonoured Payments Fees Determination 2022 (No 2)*.

2 Commencement

This instrument commences the day after its notification.

3 Revocation

Disallowable instrument DI2022-48, *Road Transport (General) Refund and Dishonoured Payments Fees Determination 2022 (No 1)*, is revoked.

4 Determination of fees

- (1) The fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 where the refund is made on or before 31 August 2022 is the amount for that item in column 3.
- (2) The fee payable for a thing listed in an item in column 2 of part 1 of schedule 1 where the refund is made on or after 1 September 2022 is the amount for that item in column 4.
- (3) The fee payable for a thing listed in an item in column 2 of part 2 of schedule 1 where the dishonour of the payment is processed on or before 31 August 2022 is the amount for that item in column 3.
- (4) The fee payable for a thing listed in an item in column 2 of part 2 of schedule 1 where the dishonour of the payment is processed on or after 1 September 2022 is the amount for that item in column 4.

5 Payment of fees

- (1) A fee mentioned in part 1 of schedule 1 is payable to the road transport authority by the applicant for the refund.
- (2) The fee mentioned in subclause (1) may be deducted from the fee being refunded.
- (3) A fee mentioned in part 2 of schedule 1 is payable to the road transport authority by the person who made the payment that is dishonoured.

6 Definitions

In this instrument:

credit card includes a debit card.

fee includes a charge or other amount.
