

# Radiation Protection (Fees) Determination 2022 (No 1)

## Disallowable instrument DI2022-249

made under the

**Radiation Protection Act 2006, s 120 (Determination of Fees)**

---

### **1 Name of instrument**

This instrument is the *Radiation Protection (Fees) Determination 2022 (No 1)*.

### **2 Commencement**

This instrument commences on 1 January 2023.

### **3 Determination of fees**

The fee payable in respect of each matter listed in column 3 of Schedule 1 is the amount listed for that item in column 4.

### **4 Payment of fees**

A fee listed in Schedule 1 is payable to the Territory by the person requesting the goods or service listed.

The fees are exempt from Goods and Services Tax under Division 81 of *A New Tax System (Goods and Services Tax) Act 1999 (Cwlth)*.

### **5 Refunding of fees**

Column 5 of Schedule 1 specifies what amount, if any, of a fee paid is non-refundable.

A non-refundable amount is included to cover the costs associated with the processing and administration of an application. As such, the non-refundable amount paid for a licence does not vary, regardless of the term of the licence.

## **6 Licence and registration terms**

The amounts listed in column 4 are based on a one-year licence or registration.

Subject to some limitations, licences and registrations can also be issued for longer terms, up to a maximum duration of three years. Where a longer term is granted, the applicable fee in column 4 is multiplied to correspond with the term of the licence or registration.

For example, the fee payable for a two-year licence is twice the fee specified in column 4. For a three registration, the fee in column 4 is multiplied by three.

## **7 Revocation**

This instrument revokes DI2021-266.

The fees determined are based on a one-year licence or registration. Subject to some limitations, licences and registrations can also be issued for longer terms, up to a maximum duration of three years. Where a longer term is granted, the determined fee is multiplied to correspond with the term of the licence or registration. For example, the fee payable for a two-year licence is twice the fee specified in column 4. For a three-year registration, the fee in column 4 is multiplied by three.

For every licence or registration for which a fee is payable, there is a non-refundable amount that has been included to cover the costs associated with the processing and administration of the application. Such costs are incurred by the regulator irrespective of whether the application is granted or refused.

The non-refundable portion of the fee is not affected by the term of the licence or registration. Accordingly, the fee to be paid for a three-year licence will have the same non-refundable amount as a one year licence.
