### 1 Name of instrument

This instrument is the *Veterinary Practice (Fees) Determination 2023 (No 1)*.

### 2 Commencement

- (2) Section 6 commences on 30 June 2023.

## Veterinary Practice (Fees) Determination 2023 (No 1)

### Schedule 2 - Category of Premises

Category of Premises	Description of veterinary services offered at premises
1	Veterinary consulting rooms where a restricted act of veterinary science (other than major veterinary surgery or emergency care) may be carried out.
2	Veterinary clinics where a restricted act of veterinary science, including major veterinary surgery, may be carried out.
3	Mobile veterinary clinics are a vehicle, including a trailer, that may be moved from one location to another, and is modified to operate as a veterinary clinic.
4	Veterinary hospitals where a restricted act of veterinary science, including major veterinary surgery and emergency care, may be carried out, and higher level of diagnostic facilities than are available at a veterinary clinic are provided.
5	Mobile veterinary hospitals are a vehicle, including a trailer, that may be moved from one location to another, and is modified to operate as a veterinary hospital.

\*Major veterinary surgery s.71(2) means a restricted act of veterinary science that-

(a) includes the carrying out of a procedure that-

(i) according to current standards of veterinary practice, should not be undertaken without the administration of an anaesthetic (other than a local anaesthetic); or

(ii) involves a spinal anaesthetic; or

(b) is prescribed by regulation.
