### 1 Name of instrument

This instrument is the *Juries (Payment) Determination 2024*.

### 2. Revocation

This instrument revokes the *Juries (Payment) Determination 2023* [DI2023-175] effective from day of commencement.

### 3 Commencement

This instrument commences on the day after its notification day.

### 4 Determination of payment

In accordance with section 49 of the *Juries Act 1967*, the amount payable for a matter stated in an item in schedule 1, column 2 is the amount stated in the schedule, column 3 for that matter.

In accordance with section 51 of the *Juries Act 1967*, the amount payable for a matter stated in an item in schedule 2, column 2 is the amount stated in the schedule, column 3 for that matter.
