

# Road Transport (Public Passenger Services) Maximum Fares for Taxi Services Determination 2024 (No 1)

## Disallowable instrument DI2024-199

made under the

*Road Transport (Public Passenger Services) Act 2001*, section 60 (Power to determine taxi fares)

### 1 Name of instrument

This instrument is the *Road Transport (Public Passenger Services) Maximum Fares for Taxi Services Determination 2024 (No 1)*.

### 2 Commencement

This instrument commences on 1 July 2024.

### 3 Determination

I determine that the maximum fares relating to the hiring or use of a taxi are as specified in column 4 of schedule 1 to this instrument.

### 4 Payment of Fare

A fare to which this determination applies is payable by a customer for using taxi services and is payable to the taxi driver with the exception of the lift fee, which is payable by the ACT Government to the taxi driver.

### 5 Revocation

This instrument revokes the *Road Transport (Public Passenger Services) Maximum Fares for Taxi Services Determination 2023 (No 1)* DI2023-303.
