# Public Health (Fees) Determination 2025 (No 1)

### Disallowable instrument DI2025-299

made under the

Public Health Act 1997, s 137 (Determination of fees)

#### 1 Name of instrument

This instrument is the *Public Health (Fees) Determination 2025 (No 1)*.

#### 2 Commencement

This instrument commences on 1 January 2026.

#### 3 Determination of fees

I determine the fees for the Public Health Act specified in Schedules 1 to 5. The fee payable in respect of each matter listed in column 2 of a schedule is the amount listed for that item in column 4.

#### 4 Payment of fees

A fee listed in a schedule is payable to the Territory by the person identified in column 3 of the schedule.

The fees are exempt from Goods and Services Tax under Division 81 of *A New Tax System (Goods and Services Tax) Act 1999* (Cwlth).

#### 5 Refunding of fees

Column 5 of the schedules specifies what amount, if any, of a fee identified in column 4 is non-refundable.

A non-refundable amount is included to cover the costs associated with the processing and administration of an application.

#### 6 Licence and registration terms

The amounts listed in column 4 are based on a one-year licence or registration.

Subject to some limitations, licences and registrations can also be issued for longer terms, up to a maximum duration of three years. Where a longer term is granted, the applicable fee in column 4 is multiplied to correspond with the term of the licence or registration.

For example, the fee payable for a two-year licence is twice the fee specified in column 4.

#### 7 Definitions

The following terms apply to the Schedules:

*charity* means a charity endorsed under subdivision 50-B of the *Income Tax Assessment Act 1997 (Commonwealth)* 

community pharmacy means a community pharmacy as defined by the Medicines, Poisons and Therapeutic Goods Act 2008

dentist means a dentist as defined by the Legislation Act 2001

*dental facility* means a premises where the predominant business activity is dentistry provided by a dentist

*medical practitioner* means a medical practitioner as defined by the *Legislation Act 2001*.

#### 8 Revocation

This instrument revokes DI2024-306.

The fees determined are based on a one-year licence or registration. Subject to some limitations, licences and registrations can also be issued for longer terms, up to a maximum duration of three years. Where a longer term is granted, the determined fee is multiplied to correspond with the term of the licence or registration. For example, the fee payable for a two-year licence is twice the fee specified in column 4. For a three-year registration, the fee in column 4 is multiplied by three.

For every licence or registration for which a fee is payable, there is a non-refundable amount that has been included to cover the costs associated with the processing and administration of the application. Such costs are incurred by the regulator irrespective of whether a licence or registration is granted or refused. The non-refundable portion of the fee is not affected by the term of the licence or registration. Accordingly, the fee to be paid for a three-year licence will have the same non-refundable amount as a one-year licence.
