This instrument revokes all existing fees determination under the Motor Traffic Act 1936, namely,-

Determination No 43 of 1995 of 9 June 1995 notified in the ACT Gazette No S133 of 22 June 1995

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees for drivers licences Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to Drivers' licences

The majority of fees have increased in line with the Consumer Price Index There are some exceptions, however, where fees have been rounded to the nearest dollar or increased to recover costs The fees reflect the 1996-97 budget strategy of the Government and will take effect from 1 July 1996
