#### EXPLANATORY STATEMENT

This instrument revokes all existing fee determinations under the Motor Traffic Act 1936, namely,-

Determination No 166 of 21 December 1995 notified in the ACT Gazette No S325 of 29 December 1995

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme which the ACT Government is required to enforce under the Road Transport Charges (Australian Capital Territory) Act 1993 (Cwth)

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of increasing fees payable for transactions which relate to vehicle registration. Set out below for easy reference are the new fees (and previous fees) which apply to transactions relating to vehicle registration

The majority of fees have increased in line with the Consumer Price Index There are some exceptions, however, where fees have been rounded to the nearest dollar, increased to recover costs or brought into line with fees charged in NSW The fees reflect the 1996-97 budget strategy of the Government and will take effect from 1 July 1996
