**DETERMINATION OF FEES 1993**

**No. 62 of 1993**

**EXPLANATORY STATEMENT**

This instrument revokes all existing determinations under section 4A of the Machinery Act 1949, namely

Determination notice dated 6 July 1992 published in Australian Capital Territory Gazette No. S115

This determination sets fees for the purposes of the Machinery Act 1949 and has the effect of increasing fees for the annual inspection of boilers and pressure vessels and the issue of boiler attendant's certificates. There are fee increases of approximately 3% to that determined in Gazette No. S115. The fees are set out below with previous fees shown in brackets.

2) Boilers (other than locomotive, traction engine or road roller boilers) having a heating surface, including economiser and superheater (if any)

c) exceeding 5 square metres but not exceeding 15 square metres	\$83.00	(\$82.00)

**Other**

*Exempted Vessels*

1) For an inspection required to be performed on any vessel eligible for exemption, the fee payable shall be	\$190.00	(\$185.00)

*Single Inspections*

1) Notwithstanding any other provision of this paragraph, where in one day in any premises an inspection is made of:

a) only one boiler and no pressure vessel, or (same arrangement as 1992/93)

b) only one pressure vessel and no boiler, and the boiler or pressure vessel inspected is one referred to in Inspection of Boilers subparagraph 2(a) and Inspection of Pressure Vessels subparagraph 1(a) and (b), and 2(a) and (b), the fee to be charged for the inspection shall be 50 percent in excess of the fee otherwise payable (same arrangement as 1992/93)

*Multiple Inspections*

1) Notwithstanding any other provisions of this paragraph, where in any one day in any premises 5 or more boilers or 5 or more pressure vessels are inspected, the fee to be charged for the inspection shall be 30 percent less than the fees otherwise payable (same arrangement as 1992/93)
