This is the first year of operation of the Land (Planning and Environment) Act 1991 and therefore comparable fees for last year are not available. Wherever possible comparative fees for similar operations under the City Area Leases Act 1936, which was the legislation in force last year, have been included.

The fees and charges have been increased in line with the principles of cost recovery though tempered to maintain increases in line with the expected rise in the level of the Consumer Price Index.
