EXPLANATORY STATEMENT

This instrument revokes all existing fee determinations under the Weights and Measures Act 1929 published in the Australian Capital Gazette No S56 on the 1 July 1991.

The fees determined in the attached schedules have the effect of increasing charges for the inspection of weighing and measuring instruments and introducing new fees for the licencing of servicing companies, public weighbridges and for the use of Trading Standards equipment to promote fair trading in the ACT.
