Health Records (Privacy and Access) (Fees) Determination 2007 (No 2)

Disallowable instrument DI2007-197

made under the

Health Records (Privacy and Access) Act 1997, s 34

This Determination of Fees revokes and replaces the Determination of Fees DI2007-59, dated 22 February 2007.

The Determination comes into effect from the day after notification and reproduces Determination DI2007-59 except for:

- Items in attachment A have been increased by the estimated 2007-08 Wage Price Index (4%) rounded to the nearest dollar;
- Updating the reference to the *Health Act 1993* fee determination section number in relation to fees for access to health records by a consumer's solicitor or insurer;
- Incorporating GST exemption within section 7 Schedule of Fees; and
- the date of effect.
