CANBERRA SEWERAGE AND WATER SUPPLY REGULATIONS (AMENDMENT)

EXPLANATORY STATEMENT

No. 35 of 1982

The Canberra Sewerage and Water Supply Regulations (Amendment) increase the fees and monetary limitations contained in the Canberra Sewerage & Water Supply Regulations. Details of the increases are set out below.

Regulation 1 amends regulation 15 of the Canberra Sewerage & Water Supply Regulations as follows:

Regulation 2 amends regulation 18 of the Canberra Sewerage and Water Supply Regulations as follows:

Regulations 3 amends regulation 20 of the Canberra Sewerage and Water Supply Regulations as follows:
