## MOTOR VEHICLE (THIRD PARTY INSURANCE) REGULATIONS

### EXPLANATORY STATEMENT

No. 8 of 1979

The proposed Motor Vehicle (Third Party Insurance) Regulations 1979 No. will increase the maximum allowable third party insurance premiums under the Motor Traffic Ordinance 1936, as recommended by the ACT Third Party Insurance Premiums Advisory Committee.

Regulation 16 of the Motor Vehicle (Third Party Insurance) Regulations (the principal Regulations) is amended to increase the maximum premium that may be charged in respect of a third party policy in relation to a trader's plate from \$100.00 to \$131.00.

The First Schedule of the principal Regulations is amended by substitution of a new Part II to increase the maximum premium that may be charged in respect of a third party policy for a motor vehicle of any classification expressed in Part I of that Schedule. The following table lists the motor vehicle classifications and sets out in respect of each the previous maximum premium and the amended maximum premium.
