# **REVOCATION AND DETERMINATION OF FEES**

## EXPLANATORY STATEMENT

## **INSTRUMENT NO. 99 OF 2001**

This Instrument revokes Instrument No. 29 of 2001, dated 20 February 2001 and notified in the Gazette No. S10 on 28 February 2001.

It has the effect of determining fees, payable in advance, for transactions relating to vehicle registration under the *Road Transport (Vehicle Registration) Regulations 2000.* 

The registration fees have been reduced by \$58 for all vehicle types except the following:

- Tractors;
- Trailers;
- Motor implements;
- Veteran, Vintage and Historic vehicles;
- Motor bikes 100ml or less.

The registration fees for the above four vehicle types are unchanged from the 2000/2001 fees, except for motor bikes less than 100ml, which have been reduced by \$15 to equal the fee for larger motor bikes.

The administration charges have been increased by the consumer price index. The Road Rescue fee and inspection fees are unchanged.

For the purposes of determining the number of trailers that a prime mover or truck may tow: (a) a converter dolly and a semi trailer when used together are to be regarded as one trailer; and (b) a low loader dolly and a low loader when used together are to be regarded as one trailer.
