REVOCATION AND DETERMINATION OF FEES
EXPLANATORY STATEMENT
INSTRUMENT No. 316 OF 2000

This Determination made under section 9A of the **Roads and Public Places Act 1937** (the Act) revokes the existing Determination of Fees and sets the fees for the purposes of the Act.

The purpose of this fee is for:

- (a) the opening up or the breaking of the surface of a carriageway which has a surface of the type listed in the description; and
- (b) the fee for the opening up or the breaking of the surface of a public place, other than a carriageway, which has the type of surface as listed in the description.

The determination is a disallowable instrument for the purpose of section 10 of the *Subordinate Laws Act 1989*.
