DETERMINATION OF FEES
INSTRUMENT NO. 204 OF 2000.

EXPLANATORY STATEMENT

The Business Names Act 1963 provides for the registration of business names in the Australian Capital Territory. In particular, section 4A of the Act enables the Minister to determine fees for the purposes of the Act.

This determination revokes Determination of Fees No. 159 of 1999 made on 22 June 1999 and notified in the Australian Capital Territory Gazette No. S38 of 30 June 1999 and determines that the fees payable for the purposes of the Act shall be as set out in the Schedule to the Determination.

The fees determined for items 1, 2, 3, 6(ii) have been increased by a margin of 2.5% in accordance with the anticipated movement in 2000/2001 of the Consumer Price Index and with a view to full cost recovery. The fees for item 6(I) has been \$15 for the last two financial years and is now increased to \$16 to reflect Consumer Price Index changes on a biennial basis (2.5% for 1999/00, and anticipated 2.5% for 2000/01) and with a view to full cost recovery. The fees determined for items 4, 5, 7, 8 and 9 have not been increased as the CPI adjustment is less than 50 cents.
