**REVOCATION AND DETERMINATION OF FEES**  
**EXPLANATORY STATEMENT**  
**INSTRUMENT NO. 185 OF 2000**

This Instrument revokes Instrument No. 78 of 2000, dated 25 February 2000 and notified in Gazette No. S6 of 29 February 2000.

It has the effect of determining fees, payable in advance, for transactions relating to driver licensing under the *Road Transport (Driver Licensing) Regulations 2000*. Licensing fees for all types of licences are unchanged. Some other fees, such as fees for a practical driving test or a replacement licence, have been increased by the consumer price index (CPI) of 2.5% and rounded for administrative convenience. The fees reflect the 2000-01 budget strategy of the Government and will take effect from 1 July 2000.

A practical driving test booking or change of a test booking, and extracts from, or searches of, licensing records attract the Goods and Services Tax of 10% which is included in the fee shown in the relevant last column.

Set out below for easy reference are the new fees (and previous fees).
