DOG CONTROL ACT 1975

REVOCATION AND DETERMINATION OF FEES

EXPLANATORY STATEMENT

INSTRUMENT No. 173 OF 2000

This Determination made under section 40A of the Dog Control Act 1975 (the Act) revokes the existing Determination of Fees and sets the fees for the purposes of the Act.

The Dog Control Act 1975 regulates the ownership of dogs within the ACT and sets fees for:

- . the registration of a dog;
- . replacing a tag or certificate of registration;
- . a licence for keeping a dangerous dog;
- . the return and transport of a dog impounded under the Act;
- . providing a certified copy of a certificate of registration;
- . viewing the register;
- . impounding a dog.

Fees for the return of an impounded dog have been simplified and aligned more closely with the actual costs involved in holding dogs at the pound.

To encourage responsible disposal of unwanted dogs Domestic Animal Services will be providing new services in relation to euthanasing and disposing of those dogs. Fees for these services are set by this determination.
