# Casino Control (Fees) Determination 2023

## Disallowable Instrument DI2023–181

made under the

**Casino Control Act 2006, section 143 (Determination of fees)**

## EXPLANATORY STATEMENT

---

The *Casino Control Act 2006* (the Act) regulates the operation of the casino in the Territory.

This instrument revokes the determination of fees made by Disallowable Instrument DI2022-131, the *Casino Control (Fees) Determination 2022*.

Section 143 of the Act provides that the Minister may determine fees for the Act. This instrument provides for fees in relation to administrative tasks performed under the Act, including matters relating to the casino licence and applications for casino employee's licences and variations to these licences.

The new determination sets the fees that will apply beginning on 1 July 2023 and repeals the *Casino Control (Fees) Determination 2022* DI2022-131. It provides for fee increases in line with annual adjustments to the Wages Price Index (WPI) of 3.75%, rounded down to the nearest dollar for most fees, with the exception of fees that have been consecutively rounded down in previous years by more than \$1.00 which have been rounded up to the nearest dollar.

This approach aligns with the 2022 Treasury Guidelines for Fees and Charges.

The list of items for which fees are set in this instrument is identical to the list of items in Disallowable Instrument DI2022-131.

The Attachment to this Explanatory Statement lists the fees previously determined to enable comparison.
