**DETERMINATION OF REGISTRATION FEES**  
**INSTRUMENT NO. 79 OF 2000**  
**EXPLANATORY STATEMENT**

As a result of the repeal of the *Motor Traffic Act 1936* and related legislation, all fees and charges are re-determined under the new Road Transport legislation.

This instrument has the effect of determining fees, payable in advance, for transactions relating to vehicle registration under the *Road Transport (Vehicle Registration) Regulations 2000*. The fees listed are the same as previously determined under the *Motor Traffic Act 1936* with the exception of the 'late transfer fee' and the fee for the replacement of an identification label (issued to holders of trader's plate). The late transfer fee is introduced to discourage new operators from transfer of registration more than 14 days after the date of purchase. This is important to ensure that speed camera and parking infringements can be directed to the appropriate person.

This instrument does not affect the fees listed in Part 2 of the Schedule to the *Road Transport Charges (Australian Capital Territory) Act 1993* (Commonwealth) which the ACT Government is required to collect for vehicles with a GVM in excess of 4.5 tonnes.

This Determination commences on 1 March 2000.
