Race and Sports Bookmaking (Fees) Determination 2024

Disallowable Instrument DI2024–143

made under the

Race and Sports Bookmaking Act 2001, section 97 (Determination of fees)

EXPLANATORY STATEMENT

The *Race and Sports Bookmaking Act 2001* (the Act) regulates the activities of race and sports bookmakers within the ACT.

This instrument revokes DI2023-130, the *Race and Sports Bookmaking (Fees) Determination 2023*.

Section 97 of the Act provides that the Minister may determine fees for the Act. This instrument provides for the fees for approvals under the Act as well as the licensing arrangements of race bookmakers, race bookmaker's agents, sports bookmakers and sports bookmaker's agents.

The new determination sets the fees that will apply beginning on 1 July 2024 and repeals the *Race and Sports Bookmaking (Fees) Determination 2023* DI2023-130. Fees in the 2024-2025 financial year have been generally increased from fees in the previous financial year by the Wages Price Index (WPI) of 3.50%, plus an additional 0.35%, rounded down to the nearest dollar. Some smaller value fees maybe rounded up to the nearest dollar. This approach also aligns with the *2023 Treasury Guidelines for Fees and Charges*.

Explanatory notes in the attachment list the fees previously determined to enable comparison.

A determination under section 97 of the Act is a disallowable instrument and must be tabled in the Legislative Assembly.
