DANGEROUS GOODS ACT 1984
REVOCATION AND DETERMINATION OF FEES
EXPLANATORY STATEMENT
INSTRUMENT No. 136 OF 1999

This Determination made under section 12A of the Dangerous Goods Act 1984 (the Act) revokes the existing Determination of Fees and sets the fees for the purposes of the Act.

The fees for issue or renewal of license under sections 8, 17, 19 and 21 of the Dangerous Goods Act (NSW) 1975 and regulations 13 of the Dangerous Goods Regulations (NSW) 1975 and the fees for Approval under section 41(1) of the Dangerous Goods Act (NSW) 1975 have increased as a result of CPI adjustments in accordance with Government policy.

The fees for issue or renewal of license under sections 10 of the Dangerous Goods Act (NSW) 1975 and regulations 13 of the Dangerous Goods Regulations (NSW) 1975 and the fees for Approval under section 11(3)(p)(i) of the Road Transport Reform (Dangerous Goods) Act 1995 (Cwth) have been maintained at the existing level. The Road Transport Reform (Dangerous Goods) Act 1995 (Cwth) is template legislation imposed by the Commonwealth. Any changes to fee levels can only be done in conjunction with the Commonwealth. Similarly, Section 10 of the Dangerous Goods Act (NSW) 1975 mirrors provisions contained in the Commonwealth legislation. Any changes are subject to Commonwealth agreement.

The result will be an increase in revenue for the ACT.
