DETERMINATION OF REGISTRATION FEES

INSTRUMENT NO. 105 OF 1999

EXPLANATORY STATEMENT

This determination revokes Determination No. 234 of 26 October 1998 and notified in Gazette No. 44 of 4 November 1998.

Registration fees for tow trucks, goods trailers and fixed load trailers have been increased to maintain parity with the equivalent fees charged in NSW.

Registration fees for passenger and goods vehicles, and fixed load vehicles with a gross vehicle mass of 4.5 tonnes or less have not been changed. They are consistent with the equivalent fees in NSW.

Where other fees have been increased, the increase is in line with the Consumer Price Index, rounded to the nearest whole dollar amount.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth).

Set out below for easy reference are the new fees and previous fees which apply to transactions relating to vehicle registration. This Instrument commences operation on 1 July 1999.
