DETERMINATION OF REGISTRATION FEES

INSTRUMENT NO. 234 OF 1998

EXPLANATORY STATEMENT

This determination revokes Determination No. 184 of 29 July 1998 and notified in Gazette No. S179 of 31 July 1998.

This Determination does not affect the fees charged in the National Heavy Vehicle Registration scheme (for vehicles with a GVM in excess of 4.5 tonnes) which the ACT Government is required to enforce under the *Road Transport Charges (Australian Capital Territory) Act 1993* (Cwth).

The Determination sets fees for the purpose of the *Motor Traffic Act 1936* and has the effect of changing fees for transactions relating to the inspection fees for motor vehicles exceeding 4.5 tonnes GVM.

Set out below for easy reference are the new fees and previous fees which apply to transactions relating to vehicle registration. This Instrument commences operation on 1 January 1999.
