# AUSTRALIAN CAPITAL TERRITORY BUSINESS NAMES ACT 1963

### **DETERMINATION OF FEES**

#### **INSTRUMENT NO. 203 OF 1998**

## **EXPLANATORY STATEMENT**

The Business Names Act 1963 provides for the registration of business names in the Australian Capital Territory. In particular, section 4A of the Act enables the Minister to determine fees for the purposes of the Act.

This determination revokes Determination of Fees No. 204 of 1997 made on 29 August 1997 and notified in the Australian Capital Territory Gazette No. S265 of 9 September 1997 and determines that the fees payable for the purposes of the Act shall be as set out in the Schedule to the Determination.

The fee determined for item 3 has been increased by a margin of \$10.00 as a result of a Budget Cabinet Decision.

The fee determined for item 1 has been increased by a margin of 1.8% in accordance with the anticipated movement in 1998/99 of the Consumer Price Index and with a view to full cost recovery. The fee for item 6(i) has been \$14 for the last two financial years and is now increased to \$15 to reflect Consumer Price Index changes on a biennial basis (1.75% for 1997/98 and anticipated 1.8% for 1998/99) and with a view to full cost recovery.

The fees for items 2, 4, 5, 6(ii), 7, 8 and 9 have not been increased as the CPI adjustment is less than 50 cents.
