#### **DETERMINATION OF FEES**

### **INSTRUMENT NO. 202 OF 1998**

#### **EXPLANATORY STATEMENT**

The Associations Incorporation Act 1991 governs the incorporation of associations in the Australian Capital Territory. In particular, section 126 enables the Minister to determine fees for the purposes of the Act and section 125 specifies matters in the Act for which a determined fee is payable.

This Determination revokes Determination of Fees No. 203 of 1997 made on 29 August 1997 and notified in the Australian Capital Territory Gazette No. S265 of 9 September 1997 and determines that the various fees payable under the Act, including fees for lodging for registration and searching documents, shall be as set out in the Schedule to the Determination.

The fee determined for the items 1 has been increased by a margin of 1.8% in accordance with the anticipated movement in 1998/99 of the Consumer Price Index and with a view to full cost recovery.

The fee for item 11 has been \$24 for the last two financial years and is now increased to \$25 to reflect Consumer Price Index changes on a biennial basis (1.75% for 1997/98 and anticipated 1.8% for 1998/99) and with a view to full cost recovery.

The fees determined for items 2 - 10 have not been increased as the CPI adjustment is less than 50 cents.
